1. Relevant Dates

2. Capacity Auction Details

GBE is implementing the GridShare Program at **Preston TS, Galt TS and MTS#1**. Details of the *target auction capacity, obligation period* and *availability window* for 2026 are set out in Table 2 below.

3. Capacity and Performance Payments*

The *capacity auction reference price, contracted monthly activations, capacity incentive payment price* and *emergency activation payment price* for the 2026 *obligation period* are set out in Table 4.

4. Non-Performance Factor

The non-performance factor for the 2026 *obligation period* is a number between 1.0 and 2.0, depending on the month of the year, and accounts for the severity of the grid constraint during a particular month. Values for the non-performance factors are set out in Table 5.
